## TERMS AND CONDITIONS OF THE TENDER

- 1. All the bidders will have to submit sealed tender for the terms on or before 16-12-2024 before 2.30 PM at office of the Director, MIDS, 79, 2<sup>nd</sup> Main Road, Gandhi Nagar, Adyar, Chennai 600 020 and the cover should be subscribed as quotation for "Used Office Furniture and Building Materials Scrap". The sealed tender will be opened in the presence of the bidders on the same day at 3.30 PM.
- 2. The materials offered for bid is strictly "AS IS WHERE BASIS". Hence, bidders should inspect the items before submitting the bid. They can visit MIDS office premises at 79, 2<sup>nd</sup> Main Road, Gandhi Nagar, Adyar, Chennai 600 020 and inspect the items kept in the identified places on any working day between 10 AM and 5 PM from 06-12-2024 to 15-12-2024.
- 3. All applicable taxes are payable by the successful bidder. However, the sales certificate will be issued by the MIDS, if required.
- 4. The Institute reserves the right of accepting or rejecting any or all the bids received without assigning any reasons to the bidders. The decision of the Director, MIDS shall be final and legally binding on all the bidders.
- 5. The Institute reserves the right to re-tender and / or conduct re-auction for any items.
- 6. The tenderer will be awarded to the bidder who quoted highest bid value.
- 7. The successful bidder is required to deposit the total bid value along with applicable taxes within two working days from the date of award of contract.
- 8. The items shall have to be removed by the bidder within 7 days from the date of issue of acceptance letter.
- 9. If the materials are not lifted beyond 7 days of issue of acceptance letter a ground rent of Rs.250/- per day will be charged.
- 10. The designated materials have to be lifted within maximum 10 days of issue of acceptance letter.
- 11. If the bidder fails to lift the material within a period of 10 days of issue of acceptance letter, the Director MIDS reserves the right to re-auction or dispose of the said Scrap in a manner, he deems fit. The amount remitted for the sale consideration of the scrap will be forfeited.
- 12. The delivery of the auctioned materials shall be taken on any working day from 10 AM to 5 PM.

- 13. In case, the bidder intends to take delivery of auctioned materials through his representative, bidder shall give the letter of authority duly countersigned by him.
- 14. The MIDS will not take any responsibility for loading and unloading of the auctioned materials etc.,
- 15. In the event of infringement of any terms and conditions by the bidder, the Institute at its discretion, will be refused to consider the bid of the concerned bidder.
- 16. If the bidder is found trying to negotiate with any Institute employees for any undue benefit, whatsoever may be the reason, the bidder will be debarred from participating in auction.
- 17. The bidders are advised to enclose the GST certificate along with the bid.
